The issue

On 20 March 2014 a Search Warrant was issued for which the basis is dubious, if not unlawful.

On 21 March 2014 Mr & Mrs Pedro were arrested without documentation or justification. They believe that the actions of Lincolnshire police were instigated as a direct result of their visit to the European Parliament in Brussels, when they requested assistance to stop the forced adoption of two and the permanent care of three of their children in the United Kingdom.

Further, Mr & Mrs Pedro consider that Lincolnshire police are attempting to impose unnecessarily long bail conditions. These are no more applicable, since negotiations between Lincolnshire County Council and the Portuguese Authorities took place on 17 April 2014.

Such action is considered to be attempts to prevent Mr & Mrs Pedro from returning to their country of origin.

Lincolnshire police have retained their passports and other documentation and it would appear that such action is now academic in light of the events on 17 April 2014.

Compensation should be paid by the defendant for the emotional harm and financial loss Mr & Mrs Pedro have suffered as a direct result of arrest, mistreatment and abuse of power by the defendant.
